We are having a training session on <u>February 4<sup>th</sup> in</u> <u>Montrose, CO</u> from Noon to 4 pm at Montrose High School. Anyone on the Western / Southern slopes of Colorado is welcome to attend.

We are training in <u>Ft. Collins</u> <u>on February 12<sup>th</sup></u>. Place and time still TBD, but it will be in the afternoon. We'll get word out when we have it figured out.

There is a training session on <u>February 26<sup>th</sup> from 9 am</u> <u>to 1 pm</u> at South Suburban Family Center at 6901 S Peoria St. Centennial, CO 80112.

If you missed the Rules Interpretation meeting (**Required for all**) on January 28<sup>th</sup>, please plan to attend one of the afore mentioned trainings. The first hour will be dedicated to the Rules Interpretation.

# Three Colorado High Schools add Girls Lacrosse for 2017 season

Holy Family, Montrose, and Rocky Mountain High Schools are adding girls' lacrosse for the 2017 season.

Holy Family in Broomfield has added girls and boys lacrosse for this season. They are coming in as an Independent and for their first season will be playing a Varsity only schedule (no JV). There are 5 teams that are Independent, and not eligible for post-season play. **Montrose High School** in Montrose, is adding girls' lacrosse this season, and will be part of the Mountain League, which will have 9 teams with this addition.

**Rocky Mountain High School** is also a new program, located in Ft. Collins. It is part of the Metro League, which has 8 schools. The other leagues in Colorado are Centennial, Continental, Jeffco, and Southern. Each of these leagues has 8 teams, except Jeffco, which has 9.

### Quick little workout for agility & core stability for Officiating

The season is upon us! Here are a few tips on getting into shape and staying in shape during the season.

Cardio: 40 square. Set up 4 cones in a box about 10 yards by 10 yards, the run around them. First run

forward, then shuffle left, then run backwards, then shuffle right. Change each time you get to a cone. Time yourself, and see how you improve over time.

**Core:** Find a set of exercises that work your entire core, and do them on a regular basis. Example: Crunch, Bridge, Heel Touch, Leg lift, Plank (hold for 30 sec).

Do all of these for count of 8, except the plank, then repeat.

Both of these exercises

will help you get conditioned for the activity of officiating. Core stability will help you be strong as you are running sideways, and the Cardio will help ensure you are in keeping up with the game as you go up and down the field.

### Attention:

The Draw begins on Wednesday, February 8th and is a multi day process that will complete on February 9<sup>th</sup>.

Anyone who has not completed training (unless you are going to the make-ups) and/or not paid dues and fees will NOT be included in the draw.

**BLOCKS:** If you don't have your blocks in before February 8th you may get scheduled for games you cannot do. This is a problem for everyone, as games that are turned back by officials end up with the inappropriate officials on those games. So <u>please</u> block your calendar in Arbiter for times you are Not Available to do games. In

addition to days, dates & times. You need to also manage: Distance (you are willing to drive to officiate a game), Sites (you don't want to go to), and Teams (you don't want to officiate).

If you do other sports in the spring: The sharing tab is under the Profile tab and allows you to authorize the sharing of assignments, in a limited way, with all of the assigners which will help prevent overlapping or double booked assignments. http://www.arbitersports.biz

# **2017 US Lacrosse Girls Rules Changes**



USL rules cover high school, college club, youth, and post collegiate club games. A number of rule changes this year center around keeping the game safe and play flowing.

Rule	Change
2-4-4	Stick checks may only be requested during a stoppage of the game clock
2-4-4	Stick checks may be requested immediately following regulation or overtime
2-7-2	Outlines changes to eyewear certification
2-7-3	Outlines ASTM headgear certification
5-2-3	Players below the restraining line on the draw may not cross until possession is established
9-1-1	Players may not use their bodies to play the ball, except with a kicking action on a non-shooting attempt
10-1-1	Looking to shoot (NOTE) has been eliminated for the Obstruction of Free Space Criteria
10-1-1	PENALTY NOTE: Penalty administration for dangerous shot and illegal shot shall be aligned with the ball
	being given to the closest defender

### Spotlight – Michelle Secor – Official & advocate for women's lacrosse in Colorado

#### Tell us about how you became involved with women's lacrosse?

While going to school at Colorado College, I saw the men and women's teams playing. It looked like a fun sport and I wanted to meet some of the guys on the men's team. <sup>(2)</sup> Seemed like a good idea at the time! Funny thing is, we borrowed sticks and I was hesitant to purchase one at that time because I didn't know if I would really keep up with it. Funny, huh?

#### When did you first become an official, and expound on the growth of lacrosse in Colorado?

Out of college I ran/organized the CC Women's Club team and I wanted to know the rules to better understand the game and then also help me on the field as a player. So I would go to the rules interpretation meetings and classes. After a while I decided I would try to make a go of it, officiating when it worked with my coaching. I started to officiate high school games probably in 2006.

#### Tell us about running the summer tournament in Vail – how it got started and growth, challenges, etc.

For two years the men organized a pick-up game for the women. I went up in 1984 to play and the guys said that it wasn't happening because no one planned it. Well I said it would happen the next year because I would organize it and have been running the women's games since. For years I would solicit people back at the club national tournament talking up the Vail Lacrosse Shootout. In 1986 we had 6 people come out from New England and we gave them players to field a team. The next year, they came out with a full team and we had a team from California too. As far as I know, that was the first time the east and west coasts met each other in the middle of the country. The turning point was in 1999 when the US National team made a stop in Colorado when they were touring Canada. After that year, word of mouth spread and it became a hot spot for lacrosse and vacationing.

#### What is your favorite lacrosse memory?

I don't have one specific moment but I think playing all of those years at the club national tournament were some of the best times. Getting to meet people from all over the country for that tournament and for the Vail Lacrosse Shootout has been the best memories for me. I love the people. We once hosted the US National Clinicians/players when they were in Colorado for a players' clinic and showed them all over the place.

#### What do you like to do in your free time and for entertainment?

I love to play a lot of sports but I do enjoy playing golf as much as I can now that I am retired from teaching. My husband and I also like live theater such as the local theater and when it is possible catch a Broadway show. I also think that any and all of the Cirque du Soleil shows are amazing and would go to all of them if I could. I have seen 10 different shows with "Mystre" and "O" topping the list. *What is your television obsession?* 

I am ashamed to say that I have many shows that I like to watch but I really do enjoy Project Runway. I absolutely love Tim Gun. Make it work!!!
